UPDATED LOOK FOR CURRENT JOBS FILE WITH NEW FEATURE - LIEN REMINDER SYSTEM

The new year saw a updated look to the Current Jobs File as a result of a significant new feature being added.

The Lien Reminder System now appears on the PROJECT tab, calculating filing deadlines for required state 1st notices and lien deadlines for private projects after simple user input of a project's beginning and end (if known) dates. "This is a feature customers have been requesting since 2005 when



TRADITION SOFTWARE purchased PreLien2Lien," said Craig Altman. "Miriam Liskin, Software Development Manager, did great work to design a simple user interface

that is powerful enough to accommodate future enhancements planned for both Bond Claim and Stop Notice reminders."

New notices for the states of KS, LA, MO, MS, NM, WY.

More new updated notices were added to PreLien2Lien in Q4 of last year, bringing the state count now to thirty-eight (38) for the states with CTT (Custom Template Technology). The new states include KANSAS, LOUISIANA, MISSOURI, MISSISSIPPI, NEW MEXICO and WYOMING. Each of the notices in these states give you the option of having the text customized for a one-time \$50 fee.

States slated to be upgraded in Q1 of 2009 include CONNECTICUT, DELAWARE, IDAHO, and IOWA.

PreLien2Lien can now print to DYMO labels.

Over the Thanksgiving holiday break, I got on my computer more than I would have liked to. I tasked Miriam Liskin, Software Development Manager for TRADITION SOFTWARE, the project of adding the capability of PreLien2Lien to print to DYMO desktop label printers. I drafted a goal of January 2009 for this new feature to be both developed and implemented successfully.

To my pleasant surprise she got done in two days a fully functioning DYMO print button on each of the legal party tabs to print a individual label. She also designed a DYMO mass print option from the LABELS drop down menu and a DYMO print menu in the CURRENT JOBS view that prints labels for only those legal parties entered for the current PROJECT being viewed.

HOW TO: Five new features in PreLien2Lien that help make you more productive

Every day that TRADTION SOFWARE employees come to work, our focus is to improve PreLien2Lien for the benefit of it's users. Using software to help you navigate a state's lien law process can appear to be imidating, especially for the new software user, or the person who has not dealt previously with construction lien law. The features below will help you use PreLien2Lien more effectively. You will feel more confident that you are using the software correctly to print the right notices, within the proper legal timeframe, to benefit your business and get your company paid faster.

- 1. Lien Reminder System At the top of the CURRENT JOBS FILE, it helps determine when you need to deliver state 1st notice and lien documents for a project. Select whether you are a Subcontractor or Prime contractor and enter the dates of the project. Clicking the "Show Reminders" button will create a deadline that you need to print, deliver or file a notice by.
- 2. DYMO label printing for legal parties on projects You now have the option to use your DYMO desktop USB label printer with PreLien2Lien. Instead of using your office printer to print labels, you can click on the DYMO Labels button in the CURRENT JOBS FILE to print labels for all legal parties of a project.
- 3. Email notices from PRINT PREVIEW For inter-office communication, you can send a print preview of a notice to other employees by e-mail. Create a print preview and click on the envelope icon in the upper left hand corner of the screen. This will create a new e-mail message with the print preview attached as a .PDF file.
- 4. Check For Updated Legal Notices on FILE dropdown menu This feature allows you to get the most up-to-date legal notices for every state. Just go to the FILE drop down menu and select "Check For Updated Legal Notices". The program will scan through our database at our website and upgrade any notices that have been changed.
- 5. Jobs Mailed 1st Notices By State (Current Jobs File) on the REPORTS dropdown menu You can generate a report of when and what projects you sent 1st notices out for certain. Click on the REPORTS dropdown menu and select "Jobs Mailed 1st Notices By State". You can either create a report for all project or only ones that are marked in the CURRENT JOBS FILE.
